

- Outstanding GCMRC REQUEST:
  - **Copy of Slides from presentations**
  - 5/20: Have GCMRC update Adjustment within 10% based on:
    - Where cuts can actually be made
    - BAHG Comments during the 4/23 and 4/25 meetings, along with the written comments in the TWG and BAHG Survey
    - Incorporate LTEMP Goal Results from TWG/BAHG Surveys
    - Include Experimental Fund Projects (as BAHG must still discuss BOR Initial Draft)
  - **GCMRC** should identify what projects are eligible to/currently receive outside funding
  - If possible, it would be helpful to receive information on who is funded by which projects, and what % of their time goes to each project/program
    - Permanent vs. term

      Guidelines/Questions
      - 1. The clarity and scientific quality of the proposal consistent with the goals established by the 2016 LTEMP Record of Decision and the need to assess resource status and trends, the effects of experimental and management actions, and potential other drivers and constraints.
      - 2. The feasibility of accomplishing the stated three-year goals and elements of each project.
      - 3. The relative priorities and funding levels proposed for the different project elements included under each project and opportunities to improve the cost effectiveness of each project given the need to reduce expenditures.
      - Contributions to the adaptive management of the resources and the experimental and management actions prioritized in the 2016 LTEMP Record of Decision (as subsequently expanded to include other methods for controlling invasive species).
      - 5. The likely readiness of the project to undergo a comprehensive review of its accomplishments and design after the completion of the FY 2025–2027 work cycle.
      - 6. Technical Merit: Any new technologies/ideas that could be incorporated.
